Management Plan and Guidelines for Students with Food Allergies, Glycogen Storage Disease and/or Diabetes

The Waterford Public Schools recognizes that food allergies, glycogen storage disease and/or diabetes may be life threatening. For this reason, the district is committed to developing strategies and practices to minimize the risk of accidental exposure to life threatening food allergens and to ensure prompt and effective medical response should a child suffer an allergic reaction while at school. The district is also committed to appropriately managing and supporting students with glycogen storage disease and/or diabetes. The district further recognizes the importance of collaborating with parents, adult students (defined as students age eighteen (18) and older) and appropriate medical staff in developing such practices and strongly encourages strategies to enable the student to become increasingly proactive in the care and management of his/her food allergy, glycogen storage disease and/or diabetes, as developmentally appropriate. To this end, the Waterford Public Schools will adopt guidelines related to the management of life-threatening food allergies, glycogen storage disease and/or diabetes for students enrolled in Waterford Public schools.
